**NOTICE TO FINANCIAL INSTITUTIONS AND LISTED BUSINESS to
UNFREEZE FUNDS/PROPERTY**

THIS NOTICE is circulated pursuant to **Section 22 AA (2) (e)** of the **Anti-Terrorism Act, Chapter 12:07 ("the Act")** whereby the Financial Intelligence Unit of Trinidad and Tobago ("*the FIUTT*") is required to maintain a Consolidated List of all orders issued by the High Court of Justice of the Republic of Trinidad and Tobago in accordance with **Section 22B (3) of the Act**, as well as to circulate same to all Financial Institutions and Listed Business.

The FIUTT hereby advises of the order of the High Court of Justice of the Republic of Trinidad and Tobago dated **June 11, 2025** as detailed in the attached Court Order No. [CV 2016 - 03975](#) and the **De-Listing** of **HAJJAJ also known as BIN also known as FAHD also known as AL AJMI also known as HIJAJ FAHID HIJAJ MUHAMMAD SAHIB AL-AJMI also known as HICAC FEHID HICAC MUHAMMED SEBIB AL-ACMI also known as HAJJAJ BIN FAHAD AL-AJMI also known as SHEIKH HAJAJ AL-AJAMI also known as HAJAJ AL-AJAMI also known as AJAJ AJAMI** from the Consolidated List of High Court Orders. This change has been effected on the TFS Search Tool and searches thereto will no longer identify the de-listed individual/entity.

THEREFORE, IT IS MANDATORY THAT:

Each Financial Institution and each Listed Business **immediately** take the following actions:

1. Verify whether it has funds or property related to the De-listed Individual/Entity which were frozen pursuant to the initial Court Order; and
2. Unfreeze the said funds or property.
